## **October Minutes**

The October 8, 2007 meeting of directors of the Alton-Godfrey Rotary Club was called to order at 5:00 p.m., by President Josh Farley. Others in attendance were, Mike Tillman, Jasper Fisher, Allen McBride, Roland Hansen, Dan Saeger, Scott Neudecker, Ron Mayhew, Rod Elias Bryan White, Tom Turpin, and the Executive Secretary Melissa Seymour.

Others in attendance were Larry Thompson and Jeannine Kelly.

On a motion by Scott Neudecker, seconded by Roland Hansen, the minutes and treasurer's report were approved.

In Club Administration, Ron Mayhew said the he would like to purchase a mic stand and a lavalier cordless mic for a cost of \$200.00. This will allow for more flexibility during presentations. On a motion by Bryan White, seconded by Tom Turpin, the board approved this purchase. There was discussion about overdue dues. It was felt that to eliminate the problem of collecting money for dues, pecans and chili that there should be two billings a year of \$145.00 to cover these costs. This would start next year. On a motion by Rod Elias, seconded by Ron Mayhew, the board approved the two billings of \$145. This will be a topic of discussion at the next Club assembly.

It was approved on a motion by Rod Elias that Alton-Godfrey Rotary is behind the mural project.

Tom Turpin reported that the dictionary project was a huge success. There were 100 dictionaries left over, and they were donated to the Boys and Girls Club and Oasis.

In Membership, the board approved the memberships of Cami Giertz and Michael Salanitro pending their attending two meetings. On a motion by Tom Turpin seconded by Rod Elias the resignation of Joel Copley, with regrets, was accepted. His resignation also creates an opening on the Board.

In new business, Bryan White is talking with Bob Van Hatten about continuing the steak fries through the winter. He will know more tomorrow. Tom Turpin said we could also hold a steak fry at Camp Warren Levis.

The meeting adjourned at 5:55 p.m.
